UNFINISHED BUSINESS

A motion was made by Jim to approve the bill payments and treasurers report. The motion was seconded by Paul and carried.

NEW BUSINESS

The board discussed the ER split (for billing purposes) between Kevin and John from Cavanaugh's. Prior to the sale of Cabin 7, in August of 2022. The ER count was 16.49 for the entire property. When cabin 7 was sold to new owners they assumed 1 ER, bringing the total count for the rest of the property down to 15.49. Jordan will reach out to Kevin and confirm how the property between him, and John has been divided.

A motion was made by Jim to approve the BLP for Caleb Connell. The motion was seconded by Paul and carried.

A motion was made by Jim to accept the planning grant offer of \$52,825 from Idaho Department of Environmental Quality (IDEQ). The purpose of this grant is to prepare a wastewater planning study in accordance with IDAPA 58.01.22 to evaluate the current wastewater system and identify needed improvements. The motion was seconded by Paul and carried. (\$52,825 is 50% of the total cost. The other 50% will be paid by the District)

A motion was made by Jim to approve the purchase of an iPad without data and Apple Care, for Chris to use to record his service calls and use mapping software once we have that available. The motion was seconded by Paul and carried.
